Trustee Levine had some questions regarding bills that were sent out for mowing residential properties that were in violation; some residents had complained about the high rates that were charged. Attorney Kaplan and Rich Manely explained that the law states that the bills are based on calculated time, materials used for the mowing or cleanup, and a 50% surcharge. The charge is meant to be punitive, so the resident will start to care for their own property. The Fees are to be based on the FEMA Chart. Equipment that gets broken is not usually charged for; example, a landscaper when mowing your lawn, if his mower breaks, he would not charge you to fix his mower. A resident is always able to challenge the fee.

Valerie Brown reported that the relevies and tax bills will be processed in July, and the tax bills will be going out for August 1, 2025 mailing. The sanitation bills are being paid, the residents are using the online payment portal.

A motion was presented by Trustee Binder, seconded by Trustee Schlesinger, to approve the Third Quarter Budget Modifications.

Attorney Kaplan has been working on the agreement with Spectrum; one of the problems is that Spectrum now only gives the Village two weeks or less to make the payment for the monthly bill. Spectrum will offer free cable to a municipality, but will not offer free internet. Attorney Kaplan will negotiate the agreement and report back to the Board.

A motion was presented by Trustee Binder, seconded by Trustee Levine, to approve the New York State and Local Retirement System, Standard Work Day Reporting Resolution for Elected and Appointed Officials, for David Schlesinger, the motion passed as follows:

Unanimous.


