would have ran in the amount of \$7300.00 but he was able to use three old meters to make a new one. Mr. Valastro reported an issue over the weekend of an overflow from a manhole. The sewer department was able to control the issue and discovered a brick had fallen in the manhole and cause the clog. Mr. Valastro reported that the digester parts were approved by engineer Will Illing and have been ordered. He stated that the repairs will be done by H20 staff to save the Village money.

Building inspector Jim Gerrard reported that there will be several people coming to court for grass cutting violations. He stated that if the grass isn't done in the time frame stated in grass cutting notice mailed to residence the Village will mow the properties and they will be fined.

Attorney Kaplan reported that engineer Will Illing's position on the water issue for Woodridge mews, after reviewing site plans, is the Village installed the system. The drainage system is clogged which is causing the runoff issue and the Village is responsible to clean it out from the road above.

Attorney Kaplan reported he is still in contact with Spectrum in regards to the billing issues, he sent a copy of the latest bill and is waiting for response.

Attorney Kaplan reported still no word from Camp Skwere in regards to the purchase of the village property that is being used and the hold harmless insurance agreement. Attorney Kaplan stated that he sent a letter to Camp Skwere attorney and is still awaiting a response.

Brenda Cohn reported that the Village is in the process of getting the tax bills ready for August 1st tax date.

Gloria Sanders reviewed the Peddlers permit prices for other Towns/ Villages. It was agreed to keep the current permit amount of \$100.00 per year.

Mayor Collins reminded the Board and Public of the "National Night Out" event scheduled for August 5th from 5:30pm to 8:30 pm at Krieger Park in Woodridge.

Mayor Collins reported that there was no need for the Executive session.

There being no further business, a motion was presented by Trustee Levine, seconded by Trustee Sanabria to adjourn the meeting at 1:10pm.
