Tom Decker reported that the DPW has been clearing the Rails to Trails, and filling potholes.

Jim Gerrard the building located at 2 Maple Avenue has been condemned. There are many building permits being issued.

Steven Valastro from H2O Innovations reported that the Water Department will be flushing hydrants from April $9^{th} - 26^{th}$. There might be a problem with the small screen processor at the Sewer Plant, he will keep the Board informed. The Water plant is running well.

Brenda Cohn informed the Village Board that we need to start working on Sanitation billing, the Board agreed to having a work session on April 1, 2024 at 5:30 pm, before the Village Board meeting.

Attorney Kaplan and the Village Board discussed the proposed Local Law 1, 2024, "Authorization to Conduct Video Conferencing Meetings", this would include all Village Boards.
